

# AGREEMENT TO PARTICIPATE AND AFFIRMATION OF LIABILITY RELEASE

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my participation in camping/hiking activities; (b) my participation in such activities may result in injury or illness including, but not limited to, bodily injury, disease, strains, fractures, partial and / or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owner(s), the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, Boy Scouts guide decision making, including that a guide may misjudge terrain, weather, trail and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; (d) by my participation in these activities, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, or by any other person.

I, on behalf of myself, and my personal representatives, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify the property owner listed below from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of the property of the individual listed below. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the property owner listed below.
